**Actions Required to Adjust Stakeholder Committee Membership**

A review of the initial membership selected for the Stakeholder Committee determined that the several adjustments to the Committee membership are needed to address the following concerns:

1. Several of the stakeholder categories had more than one representative from the same organization or type of organization. By having this situation, there may have been some divergent interests that were not afforded a seat on the Stakeholder Committee.
2. In the Property Owner category, there was an absence of property owners primarily interested in economic utilization of their property.
3. There is no County Government representative in the Governmental Entities group on the Stakeholder Committee.
4. Neighborhood Group representation is not geographically diverse.

**Accordingly, all interested Stakeholders from the following category groups are asked to meet at 6:00 pm on Wed, July 21, 2004, at the Austin Community College (ACC), Pinnacle Campus, to make the changes listed below:**

**Property Owners:**

- ACTIONS: (1) Name an additional (4<sup>th</sup>) stakeholder representative to represent property owners primarily interested in economic utilization of their property.  
(2) Name a replacement stakeholder representative for one of the two Hamilton Pool Road Scenic Corridor Coalition representatives.

**Development Interests:**

- ACTION: Name a replacement stakeholder representative for one of the two RECA representatives.

**Neighborhood Interests:**

- ACTIONS: (1) Name a replacement stakeholder representative for one of the two Hamilton Pool Road Scenic Corridor Coalition representatives.  
(2) Consider changes to the representation to ensure geographical diversity across the region.

**Governmental Entities:**

- ACTION: Name an additional (4<sup>th</sup>) stakeholder representative to represent county government interests.

**Local Environmental Preservation/Good Governance Organizations:**

- ACTION: Name a replacement stakeholder representative for one of the two Save Barton Creek Association representatives.

**Please understand that the intent of the proposed changes is to ensure that divergent interests have a voice on the Stakeholder Committee and that the changes are in no way intended to deny or restrict the voice of anyone else. We appreciate your participation in and cooperation with this effort.**
